



## FORMAL OPINION

### **On the amendment of the State aid scheme enforced through the *Government Decision no. 753/2008 for the setup of a regional development State aid scheme for the promotion of investments***

By analyzing the following:

The Draft of Government Decision for the amendment of the *Government Decision no. 753/2008 for the setup of a regional development State aid scheme for the promotion of investments*

and

Annex no. II – simplified notification form, for the State aid measures enclosed in the Draft of Government Decision for the amendment of the *Government Decision no. 753/2008 for the setup of a regional development State aid scheme for the promotion of investments*,

submitted by the Ministry of Public Finance by the address no. 476385/30.10.2013, registered at the Competition Council with no. RG 13066/04.11.2013, in order to receive a formal opinion,

and

ascertaining that:

1. On 25.02.2008 Romania has notified to the European Commission the State aid measures enclosed in the *Government Decision no. 753/2008 for the setup of a regional development State aid scheme for the promotion of investments*.

The European Commission has authorized the State aid by the Decision no. C (2008) 3158 final, on 02.07.2008.

By the Decision no. C(2012) 9780 final/17.12.2012 the European Commission has authorized the prolongement, until 31.12.2013, of the validity of the State aid scheme set-up through the GD no. 753/2013.

2. The facilities set-up by the notified State aid scheme are granted to those large undertakings fulfilling, simultaneously, the following conditions:

- make an initial investment amounting more than the equivalent in lei of 100 mil. Euro, and the amount of eligible costs exceeds the equivalent in lei of 50 mil. Euro;
- create at least 500 new jobs as a result of the initial investment made.

3. Bugetul schemei este de 575 milioane de euro, echivalent în lei. Numărul maxim estimat de beneficiari este de 20 de întreprinderi. The scheme's budget amounts 575 mil. Euro, equivalent in lei. The maximum number of beneficiaries is of 20 undertakings.

4. The scheme set-up through the GD no. 753/2008 is to be applied until 31 December 2013, with the fulfilment of the conditions provisioned for in the European Commission's Decision no. C (2012) 9780 final. (*Decision no. 166 of 10 April 2013 for the application of the provisions of the European Commission's Decision no. C (2012) 9780 final*).

5. The Draft of Government Decision submitted to the Competition Council does not make any amendments to the State aid granting conditions and does not modify the budget of the scheme, the sole amendments aiming the prolongation of the scheme until 31 June 2013.

6. The notification is completed in accordance with the standard forms enclosed in Annex II to the *Regulation (EC) no. 794/2004 implementing Council Regulation (EC) no. 659/1999 laying down detailed rules for the application of Article 93 of the EC Treaty*, with the subsequent modifications and completions.
