### FORMAL OPINION

#### **on the draft of state aid scheme “Financing RDI projects according to the Program *Development of National Research and Development*”**

By analysing

The draft of state aid scheme "Financing RDI projects according to the Program *Development of National Research and Development*"

and

The draft of summary information sheet regarding State aid granted under *Commission Regulation (EU) no 651/2014 declaring certain categories of aid compatible with the internal market in application of Articles 107 and 108 of the Treaty*<sup>1</sup>,

Submitted by the Ministry of National Education – National Authority for Scientific Research and Innovation (ANCS), by letter no. 1619/5.6.2015, registered at the Competition Council with no. RG 6301/5.6.2015, in order to receive a formal opinion

and

The draft decision of the National Authority for Scientific Research and Innovation for approval of state aid schemes related to the National Plan for Research, Development and Innovation 2015-2020, registered at the Competition Council by letter no. RG 8198/9.7.2015

And ascertaining that:

1. The scheme was developed under *Commission Regulation (EU) no. 651/2014 declaring certain categories of aid compatible with the internal market in application of Articles 107 and 108 of the Treaty* and comply with the elements set out in this Regulation:
  - The scope of the Regulation;
  - Notification thresholds;
  - Maximum intensities;
  - Eligible costs;

- The requirements on transparency, cumulative incentive effect, publishing and information
2. The scheme complies with *GEO no 77 of 3 December 2014 on national procedures for state aid and amending and supplementing Law no. 21/1996<sup>2</sup>*, approved by Law no. 20/2015;
  3. The scheme supports the overall objectives stipulated in the National Strategy for Research, Development and Innovation for 2014-2020 (SNCDI 20):
    - increasing the competitiveness of Romanian economy through innovation;
    - increasing the Romanian contribution to the knowledge advancement;
    - increasing the role of science in society.
  4. The scheme contributes to the achievement of **specific objectives of Programme 1** – The development of national research and development system within PN CDI III:
    - development of human resource, infrastructure and institutions in the field;
    - increasing the efficiency of resource use in public organizations, by developing mechanisms for monitoring and evaluating the quality and relevance of RDI activities;
    - increasing the system attractiveness and opening of research organizations to the international community;
    - modernization of public administration in the research sector.
  5. **State aid grantor** is the National Authority for Scientific Research and Innovation.
  6. The authority which manages the scheme is the National Authority for Scientific Research and Innovation, through own departments, through subordinated public institution or other organizations which implement the components programs of PNCDI III, as leaders of the program.
  7. The aid is granted in the form of **subsidies (grants)**, based on a financing contract.
  8. State aid beneficiaries are legal entities which have research and/or technological development as business activity and which provide economic activities, namely activities consisting in offering goods and/or services on the market.
  9. The scheme is valid until **31 December 2020**. The payment of aid to beneficiaries can be made until 31 December 2023.
  10. The **total estimated budget** of the scheme is RON **3,600,000,000** for the period **2015-2020**.
  11. The estimated number of beneficiaries is 1000.
